A message from the superintendent

Dear Skamania Community,

On February 11, patrons will have an opportunity to vote on the Skamania School District funding measure to replace our current levy.

This local funding provides approximately 12% of our district's operating budget, which includes expenses like school counseling services, music, P.E., maintenance and operations, and administrative support. This funding is critical to the continuation of high quality education, and without it the district would be forced to make some difficult decisions.

You will have the opportunity to attend an upcoming informational session at the school on January 23rd where you can learn more. Additional dates, times and information can be found at skamaniaschooldistrict.org.

Why does the Skamania School District need levy funds every year?

The state only funds part of what it costs to provide a child's public education. The balance of the money needed is expected to come from local levies and the federal government. Our school relies heavily on local levy funds that provide approximately 12% of the Skamania School District's budget.

What will the impact be if the levy does not pass?

If the levy does not receive 50% approval, the Skamania School District would have to make some difficult decisions, which may include consolidation with another district. If that were to happen, it would mean higher tax rates that are more in line with neighboring school districts at \$2.17 per \$1,000 of assessed property value. Skamania taxpayers would miss out on the much lower tax rate proposal.

Funding causes challenges statewide

A complex new school funding model was implemented by the Washington State Legislature in 2018. It led to an increase in state funding to education but dramatically reduced the ability for districts to fund education locally, resulting in significant financial challenges for many school districts. Local funding is now more important than ever.

YOUR REPLACEMENT LEVY GUIDE

What is a Replacement Enrichment Levy?

The Replacement Enrichment Levy is a funding measure that helps bridge the gap between what the state pays for education and what it actually costs to run a school district. The Skamania School District is running a three-year replacement enrichment levy that will go before voters on February 11th. This is not a new tax; but is simply the continuation of an existing tax. The proposed levy for 2020-2023 will fund programs in our district that are either not funded or not entirely funded by the state.

Replacement Enrichment Levy Estimated Rates*

Year	Amount collected	Rate per \$1,000 of assessed valuation
2020-21	\$229,400	\$1.52
2021-22	\$229,400	\$1.50
2022-23	\$229,400	\$1.48
