Mrs. Young moved to approve the consent agenda. Mrs. Dominik Medlin second the motion. Motion passed unanimously.

Unfinished Business

- Transportation Updates

Mr. Dennison revealed that he is actively seeking to hire bus drivers whenever possible. There was one possible bus driver, but the interview had to be rescheduled because of scheduling conflicts. After driving the bus that was up for sale in the Klickitat School District, Skamania's current bus driver left feeling rather impressed. The bus is the same size as Skamania #7 diesel bus, seating 54 passengers. The diesel tank needed to be serviced because of a maintenance issue. Water had accumulated and been mixed in with the fuel. Now that the repair has been completed, everything is working.

Update on EV buses: Skamania was able to get a price for a smaller EV type C bus after speaking with the Department of Ecology. The grant language was recently received, and more information will be released after it has been reviewed.

- HVAC System Update- Tim Young

Filters:

All the filters have been replaced.

RTU-6 Repairs:

Fuses have been replaced and electrical connections tightened

RTU-8 Repairs:

Fuse blocks and fuses have been replaced as well as damaged wiring. Connections were tightened. Electrical failure likely due to loose wiring connections.

RTU-3&4:

New electrical disconnect doors need to be installed. Status of replacements. RTU-5:

This unit serves Library 132 and has been displaying an alarm message related to the unit's

refrigerant circuit. This is determined by the Refrigerant System Module. It has been Recommended that Hunter - Davisson make a service call to repair RTU-5.

- Preventative HVAC Maintenance Contract - Approval

Mrs. Dominik Medlin moved to approve the Preventative HVAC Maintenance Contract proposal from Hunter Davisson for \$7,090.00. Chairman Collins seconded the motion. The motion passed unanimously.

- May Budget Workshop

The board members were given the proposed agenda. Mr. Dennison announced that Mr. Hole, who works for ESD 112, will be attending the meeting to provide an update on the additional revenues and the budget. The ending fund balance is now anticipated to be \$420K. The board will be reviewing certificated salary expectations for the upcoming year during this workshop. Skamania abandoned the state-allocated model a few years ago. Mrs. Young asked where the state allocation model could be found.

After the board workshop, there will be a special emergency meeting. This will be done in order to learn about the scenarios and needs for education, as well as salary and innovative approaches to use the staff. It was said that every school district employs more staffing than the state provides funding for. The following school year, more recess time will be required. According to Mrs. Chavarria, the inclusion of STEAM has been a major selling factor for many families. Teachers can also benefit from prep time when they have STEAM, music, and PE classes. Additionally, a request to increase bus drivers' pay will be made. When enrollment reaches the mid 90's , the district might be eligible for an additional teacher. On Wednesday, there will be a staff meeting, Mr. Dennison announced.

New Business

- Policy 2421-Promotion/Retention/Acceleration- 2nd reading

Mrs. Young moved to approve Policy 2421 section 2000 Promotion/Retention/Acceleration. Mrs. Dominik Medlin seconded the motion. Motion passed unanimously.

- Inclement Weather Waiver Request

Mrs. Dominik Medlin moved to approve the Inclement Weather Waiver Request. Chairman Collins seconded the motion. The motion passes unanimously.

Reports

- Superintendent's Report- Milt Dennison

According to Mr. Dennison's estimate, the adjacent districts will have 15 new superintendents. A lot of superintendents are experiencing burnout. Eleven people have applied for the available teaching position. Every applicant has teaching experience. In addition, Mr. Dennison revealed that he was there for the pre-wildfire workshop. Temperatures are expected to be higher this year, and the season may be more difficult. Skamania remains utilized for helicopter landings and evacuations. Enrollment is projected to be higher next school year.

Chairman Collins agreed.

Mrs. Young said she thought Mrs. Caccavo had done a fantastic job organizing the spring concert. It was great that Karen Ditzler was acknowledged. The clarinet was played by Mrs. Chavarria. Mrs. Young received positive parent feedback. Mrs. Young went to the Chamber of Commerce meeting with Mr. Dennison. Head Start and childcare were discussed, as well as electric vehicles and buses.
